## **PROJECT UPDATE**

### **WATERMAIN AND SANITARY SEWER REPLACEMENT – M-BLOCK**

### **CITY OF BRAMPTON**

#### **What are we doing?**

- Continuation of watermain and sanitary sewer construction on Madrid Crescent including water service connections and decommissioning of the abandoned sanitary sewer.
- Completion of outstanding restoration of the boulevards and driveways.

#### **Why?**

- To upgrade the water and wastewater system capacity and reliability as part of the Region of Peel's State of Good Repair program.

#### **When?**

- We expect to start work on or about Monday May 29, 2017, with a construction crew focusing on Madrid Crescent.
- We will start restoring the road, boulevards and driveways when all water and sanitary system works are complete.

#### **Working Hours**

- Our contractor's normal working hours are from 7 a.m. to 7 p.m. These hours are consistent with the local municipality's bylaws. We understand this may cause some inconvenience, but shorter working days mean the project would take longer to complete.

#### **Traffic and Parking Control**

- We may need to reduce traffic to a single lane during construction.
- On-street parking will be reduced during construction.

#### **Driveway Access**

- Due to construction activities, we may need to block your driveway for a short time. We will contact you before we do this to arrange for the best time and for alternate access, if needed.
- Please call the Project Manager if you have special needs related to access or business hours.

### **Irrigation or Sprinkler Systems**

- Please tell the inspector if you have underground irrigation or a sprinkler system outside your property line.

### **Interrupting Your Water Supply**

- It is our goal to let you know 48 hours (2 days) in advance if we need to shut off your water. Occasionally, we may have to reduce this notice to 24 hours.

### **Vibrations**

- You may feel slight vibrations from the construction work.

### **Replacing and Taking Care of Your Sod**

- Areas of boulevard not restored in 2016 will be restored following the underground works.
- Areas of boulevard restored but with settlements will be rectified. Please notify the construction inspector if your lawn has experienced settlements following the replacement of the watermain or sanitary sewer.
- The contractor will take care of any sod replaced for 30 days.
- You can help the sod to stay healthy by watering it for one hour in the early morning or in the evening, two or three times a week. This is especially important in hot or dry weather.
- We will replace your sod as soon as we can, but there may be a short delay

### **Repairing Your Driveway**

- If we have cut your driveway, we will repair the asphalt in the disturbed area from edge to edge across the driveway. Unfortunately the Region **cannot** completely replace your driveway.
- We will repair your driveway as soon as we can, but there may be a short delay.
- **If you would like to have the rest of your driveway paved at this time, please contact either the contractor named on the front of this letter. These are the only two contacts for you. Please do not accept direct solicitation from any contractor telling you that they have been retained by the Region. Please remember this is your option. If you choose to do nothing, we will repair all areas damaged by our construction; however, we are unable to completely replace your driveway.**

### **Repairing the Road, Curbs, and Sidewalks**

- As part of the overall improvement for the M-Block, the City of Brampton shall pave these streets as part of their road resurfacing program upon the expiry of the Region's warranty period.

### **Project Updates**

- The Region of Peel will always let you know if there are any major changes to the plans.
- Please call the project manager or inspector if you have any problems or special needs.
