PROJECT UPDATE

WATERMAIN REPLACEMENT AND IMPROVEMENT LIRUMA ROAD, LOANNE DRIVE, DUNDAS STREET WEST, WESTMAN ROAD, CLEARY COURT CITY OF MISSISSAUGA

What are we doing?

 Reinstating the road, driveways, sod and curb following the replacement of the watermain and services along Liruma Road, Loanne Drive, Dundas Street West, Westman Road and Cleary Court.

Why?

• To complete restoration following upgrade of the water distribution system.

When?

- We expect to start work on or about August 8, 2017.
- The project should be completed before October 1, 2017.

Traffic and Parking Control

- We may need to reduce traffic to a single lane during construction.
- If we have to reroute traffic, we will place signs giving directions.

Driveway Access

- Due to construction activities, we may need to block your driveway for a short time. We will contact you before we do this to arrange for the best time and for alternate access, if needed.
- Please call the Project Manager or Construction Inspector if you have special needs related to driveway access.

Replacing and Taking Care of Your Sod

- The contractor will take care of any sod we replace for 30 days.
- You can help the sod to stay healthy by watering it for one hour in the early morning, two or three times a week. This is especially important in hot or dry weather.
- We will replace your sod as soon as we can, but there may be a short delay.
- It is common for the work area to settle a bit following construction. If you notice any settlement, please contact the Project Manager or Construction Inspector and we will ensure the contractor repairs it.

Repairing Your Driveway: Loanne Drive, Liruma Road and Dundas Street West Properties

- If we have cut your driveway, we will repair the asphalt in the disturbed area from edge to edge across the driveway. Unfortunately the Region **cannot** completely replace your driveway.
- We will repair your driveway as soon as we can, but there may be a short delay.
- If you would like to have the rest of your driveway paved at this time, please contact the Asphalt Sales Representative named on the front of this letter. This Asphalt Sales Representative is the only driveway contact you need. Please do not accept direct solicitation from any contractor telling you that they have been retained by the Region of Peel. Please remember this is your option. If you choose to do nothing, we will repair all areas damaged by our construction; however, we are unable to completely replace your driveway.

Repairing Your Driveway: Westman Road and Cleary Court Properties

- The City of Mississauga has scheduled Westman Road and Cleary Court for Roadway Rehabilitation in 2018 pending Council approval. During Roadway Rehabilitation works, a portion of most driveways will be disturbed again along the curb.
- If you are a resident of Westman Road or Cleary Court and we damaged a portion of your **asphalt driveway**, a temporary asphalt patch will be installed by our watermain contractor. Following the City of Mississauga's work your driveway will be replaced in the disturbed area from edge to edge across the driveway.
- If you are a resident of Westman Road or Cleary Court and we damaged a portion of your **interlock driveway**, our contractor will fully reinstate the pavers up to the temporary asphalt curb to ensure driveway material is secured until the City of Mississauga commences their works.
